**DEPOSITS  
PAYMENTS  
IDENTIFICATION/PASSPORT INFORMATION**

**DEPOSIT:** The total deposit is \$100 (non-refundable) per person. You are able to reserve your space for \$50.00 due September 30 with a second \$50.00 payment due October 30. Deposits can be paid via Visa, MC, Discover, Debit cards with Visa or MC logo. Personal checks are not accepted for initial deposit. Interim payments may be made with personal checks. Please note that there is a \$25.00 fee for NSF/returned checks and Serenity will be unable to accept future personal checks. That fee will be added to the balance due on your vacation package. A personal check may be written for final payment as long as it is received 30 days prior to the final due date. There is a \$2.00 fee for each request for lost/misplaced invoices and/or balance inquiries. All such request must be made via email.

After October 30, full deposit will be required at the time of booking:

***PLEASE NOTE THAT payments which have not been received within 5 days of the due date constitutes a cancellation. It is imperative that you keep your payment schedule handy/visible so that you know when your payments are due.***

**IDENTIFICATION/PASSPORT:** Although, currently, a passport is not needed for a closed-loop cruise, we strongly suggest that you acquire a passport. It is the best piece of identification you can have. For more information regarding passports go to [www.travel.state.gov](http://www.travel.state.gov). You do not need a passport for a closed-loop cruise which is a cruise that leaves and returns to the same port. If for some reason you miss your flight and have to fly into a non U.S. port, you will be required to have a passport.

**Insurance Information:** Serenity understands that there may be circumstances beyond your control that could possibly interfere with your travel plans. Please note that insurance is not mandatory but very strongly recommended to cover your travel investment. Insurance cost is based on the cost of the cabin. Please contact our office for insurance. If you are interested in purchasing insurance, you must purchase your policy within 10 days of your \$100.00 deposit. If you are not interested in insurance, please circle the “decline” section of your reservation form and sign the same.

Cancellations must be in writing via email. Cancellations can only be accepted from the person who is actually being invoiced. Please note that if someone is making a payment for you, Serenity can only give a credit to the person from which we received the payment. Also note that if your roommate cancels, the cost of your vacation package will increase based on the number of people remaining in the cabin. Serenity cannot take responsibility or mediate disputes between cabin mates.

If your travel plans change and you are unable to travel, you may do a name change. Name changes must be done in writing via email and must initiate from the person who currently has paid deposits on the cabin. Serenity will not negotiate payment reimbursements (if any) between the current and new traveler. Serenity will collect the outstanding balance (if any) from the new traveler.

**Invoicing:** You will receive a detailed invoice for each payment Serenity receives. **Correspondence:** You will receive correspondence and invoices via email and/or US mail. If via email, the subject line will normally state “McKinney-Ellis Reunion” so that you can identify the email.

**Cruise Cabin Upgrades:** Based on Carnival availability, we will inquire about cabin upgrades. We can make no promises or guaranties as to availability, but we do promise you that we will inquire in hopes of obtaining an upgrade on your behalf. If we are able to obtain an upgrade for you, the information will be printed on your final invoice. Please note that an upgrade does not mean that you get an ocean view instead of an inside cabin, it means that you are normally moved up a couple of decks (category change).
